

Parental conflict in the presence of children by the type of care in the Czech Republic

Theoretical framework

Czech context:

- high divorce rate (40% of marriages end in divorce, 2024)
- more than half of divorcing couples have minor children (½ under 6 years old)
- every year, approximately 20,000 children experience parental divorce
- court statistics: the share of joint/share custody increased from 9% to 30% in the last ten years (mother's sole custody decreased from 83% to 62%); 79% of court decision based on parental agreement

Literature review

- Joint custody lower incidence of parental conflict, better cooperation (Weston & Qu, 2018; Bauserman, 2002, 2012; Augustijn, 2023)
- Intensive communication potential parental conflict, stress on children (Amato & Rezac, 1994; Baude et al., 2019; Buscho, 2020; Ballnick, 2012)

What applies to the Czech Republic? Hypothesis...

- Do the parents with almost equal custody manage to avoid disputes and conflicts in the presence of their children more than those with sole custody arrangements?
- Is the degree of conflict dependent not only on the type of custody, but also on gender and other characteristics, e.g. the child's age, the educational attainment of the parents or the time elapsed since separation?



Data – Child in Parental Conflict 2021

Quantitative questionnaire survey

- The research aimed at comparing post-divorce arrangements in two different types of child custody
- The type of custody at the time of the research: defined by the number of nights the child actually spends with the respondent
 - sole custody arrangements
 - Resident parent = child spends 22 or more nights per month,
 - Non-resident parent = child spends no more than 8 nights per month
 or not at all, but still sees the child at least once per month
 - more or less equal (joint) custody
 - child spends 9 to 21 nights per month with the respondent
- 1 059 respondents with the sole custody
- 940 respondents with joint custody (more or less equally)

Conclusion

- More or less equal (joint) custody is not automatically associated with less conflict, nor sole custody with more conflict.
- Socio-demographic characteristics play a more significant role than the type of custody
 - Gender: Both resident fathers and fathers with joint custody declare more frequent conflict with the child's mother in the presence of the child.
 - Education: Higher parental education less conflict, and vice versa
 - Preschool children (under 6 years) in sole custody may occasionally be exposed to the wide range of conflict situations between their parents more *than older children* (16–18 years).
 - In joint custody children of school age (7–15 years) occasionally witness arguments and verbal abuse, and younger children (7–11 years) frequently experience violence between their parents *vs. younger (4–6 years) or older children (16–18 years)*.
 - The time that has elapsed since the separation was found to positively correlate with the calming of the relationship between the parents.
- Serious parental conflict in front of children is not a common phenomenon;
 however, in sole custody arrangement, 16% of parents have no contact at all.
 - Support for activities leading to the improvement of parental competences, mediation and parent education is still needed.
